

#### **Narrative**

#### Circumstances:

The parties involved are father SOLT, PAUL ROBERT & son SOLT, DAVID JEREMIAH whom both reside at separate addresses.

SOLT, DAVID JEREMIAH suffers from chronic fatigue and has called Police advising of alleged assault that occurred at his home address of 17 PRINCETON ROAD by his father.

There has been 1 previously recorded family harm episode including both parties.

DAVID has continued to yell several times on the phone to the Comms call taker "help" "I want bystanders to observe my father ". His father has then been heard in the background of the phone call apologising and DAVID has stated that he is leaving and requested Police to stand down as he doesn't consent to having Police on his property.

Police advised that we would be attending due to the nature of the call and this being a family harm event.

There are no court/police orders in place between the parties.

#### Mutual Participants:

SOLT, PAUL ROBERT has been identified as a mutual participant due to the disclosures made to Police.

PAUL was spoken to by Police over the phone and he was calm and cooperative with Police. He stated that he really does love his son and only wants what is best for him.

He advised Police that he had sent a text to DAVID yesterday mentioning that he was going to come and visit and that DAVID was happy with this and that he even sent a text this morning to remind him of this. He stated his moods can change so quickly due to his chronic fatigue.

He stated to Police that he is not diagnosed with any mental health illness however his whanau believe that the chronic fatigue has been messing with his brain.

PAUL mentioned he was just trying to help out today as he has just returned from being on holiday for two weeks and he was coming to the house to support DAVID in relocating and believed that DAVID was fine with him coming over.

PAUL denied the alleged assault that was mentioned and as soon as he started to hear DAVID start to scream out that PAUL was assaulting him he just knew he had to leave. He is fearful now in regards to coming back to the address because of what more things DAVID might say and falsely accuse him of.

He stated DAVID believes that the world wants to hurt him and that he gets nervous for this. He has a belief that Police will come and take him away to a nursing home. PAUL stated he doesn't want him to go to a nursing home but understands that DAVID is not allowing the people who love him support him.

#### Primary Victims / Victims:

SOLT, DAVID JEREMIAH has been identified as the primary victim in this family harm investigation in relation to the alleged assault however he has also been identified as a mutual participant due to the disclosures made to Police.

On Police arrival DAVID was waiting outside his property on the street and was approached by Police and instantly he requested that Police stay away at a spacious distance from him when speaking with him. He was cooperative when spoken to by Police in relation to todays events and had his walking stick with him.

He stated to Police that yesterday his father PAUL had told him he was going to come over for a visit but DAVID advised him he wasn't feeling too great and that he should come at another day. PAUL has not listened to this request and has arrived at the property today. PAUL has been yelling out trying to encourage DAVID to let him in/come outside. DAVID has stated to him

he doesn't want him there and that he had locked the door to prevent him from coming inside. DAVID then stated that the ranch slide window was off its latch and PAUL has gone and opened it and struck him on his left shoulder this is when he's started to continually yell out "SOLT, PAUL ROBERT is trying to get inside and I'm being assaulted, help". PAUL has then left the address and DAVID has requested Police not attend.

DAVID reiterated to Police multiple times that he was not injured from this event and that he didn't want PAUL to face criminal charges.

He also requested for the attending officers names and did this over a mobile recording outlying the events that occurred today and what outcome he wanted in relation to this. He advised Police he has trouble seeing, hearing and walking.

The scene of the incident was a single storey residential dwelling. The property was not entered into as DAVID met Police out on the footpath and stated many times he didn't want attending officers to come any closer to him.

DAVID stated there was no damage to the house and the alleged strike to his left shoulder did not hurt or leave a mark.

#### Risks and Opportunities:

SOLT, DAVID JEREMIAH reiterated to Police that he did not want PAUL to face any charges regarding this event. Due to nil injuries observed and DAVID not wanting to make any further complaint it did not meet the solicitors general guidelines for reasonable prosecution.

A PSO was considered however deemed unnecessary as PAUL had already left the address prior to Police arriving. A follow up phone call was made to Paul who advised Police that he is scared that if he goes back he will just start to say things like he has today.

PAUL reiterated to Police that DAVID often declines support however we believe that this may be beneficial for DAVID in future in regards to support his well-being.
